- The Sand Pile is getting low due to the ice that we have had this year.
- We are in the process of rebuilding the Engine on the Mac Dump Truck. The Engine Kit cost \$705 and the work can be done in house.
- The John Deere Loader is almost done. The cost of the repairs is \$17,200. The Trade in value is \$20,000-. We need to set up another date to talk with The John Deere Rep.
