- Rick took delivery of the New Loader.
- The CHIPS work is done.
- Davy Road culvert is done it just needs the guardrail.
- Hauling of the sand is about 50% done.
- Gravel has been placed on Upper Davy Road.
- Work on shoulders, ditches and patching will continue.
- The CHIPS reimbursement will be Dec. 15, 2018 and the budget level will be low until then.
- The loggers are gone on Sprague Road and it will be honed soon. Work on the seasonal road.
- US Fish & Wildlife be reviewing the culvert along Wylie Brook, there may be possible funding available if needed.
