Supervisors Report: Jennifer

- The Highway Dept. is in rough shape as far as Manpower goes. One employee is looking to retire (not exactly sure when) and Rick was hoping to do without the 4th man but at this stage of the game he needs to hire someone. He has someone in mind.
- Rick worked on shimming the North Road to bring it True and Level. Cahoon Road has had Calcium Chloride laid down to help with dust control. Wylie Horton road will have Calcium Chloride laid down soon.
- Buckley Road will possibly get shimmed on Monday of next week.

Old Business

- Jenn did more research on the replacement of the street lights with more efficient LED lights. The total cost is \$624.83 to replace all the street lights. We have budgeted \$2,800.00 for the year but we should save about \$1,735.00 annually. If we order now it is about a 12 week wait. George made a motion to have Jenn pursue replacing the lights. Marion seconded the motion. All are in favor.
- Fire Company's parking lot-In doing research Theresa found in the Contract between the Town and the Fire Company since 1978 the Town Highway Department would plow from the road down to just beyond the bay doors so that the fire equipment can get out for emergency. The concern is that now that they have a new Stone and Oiled parking lot they would want the town to fix any damage. Chief Jim Fowlston and President Kyle Griffith let the Town Board and The Highway Superintendent Rick Granger know the Fire Company will not hold the town to fix any damage done to the parking lot.
- Jenn looked into the question about a Fire Commissioner and found that we would need a minimum of 5 and they have to be elected. There was a concern how \$14,662 was actually spent. The Fire Chief invited the Board to come to any meetings the 1st Monday of the month at 7 p.m.

• The Area Agency of the Aging would like to renew the Agreement for Use of Facilities for the Senior Center/congregate meal site for 2021. All of the members of the board agree to keep the contract as usual.
